#### UAE visa (ENTRY VISA not required for the following)

## European Countries:

Andorra, Austria, Belgium, Denmark, Finland, France, Germany, Great Britain, Greece, Iceland, Ireland, Italy, Liechtenstein, Luxembourg, Monaco, the Netherlands, Norway, Portugal, San Marino, Spain, Sweden, Switzerland, and the Vatican.

#### Other countries :

USA, Canada, Australia, New Zealand, Japan, Brunei, Singapore, South Korea, Malaysia and Hong Kong.

#### **AGCC Countries :**

Nationals AGCC countries like Bahrain, Kuwait, Qatar, Oman and Saudi Arabia, FOC on arrival, Expatriate residents issued on arrival
